#### **Qualifications:**

To be eligible for the SFMNP, you must meet all the following requirements:

- You must be 60 years old or older (or 55+ if you are Native American/Alaska Native)
- Your income must be below 185% of Federal Poverty Level. That means:

o \$26,973 Annual or \$2,248 Monthly Income for 1 person

o \$36,482 Annual or \$3,040 Monthly Income for 2 people

o For larger households, add \$792 for each additional person

• You must be a resident of Washington State
